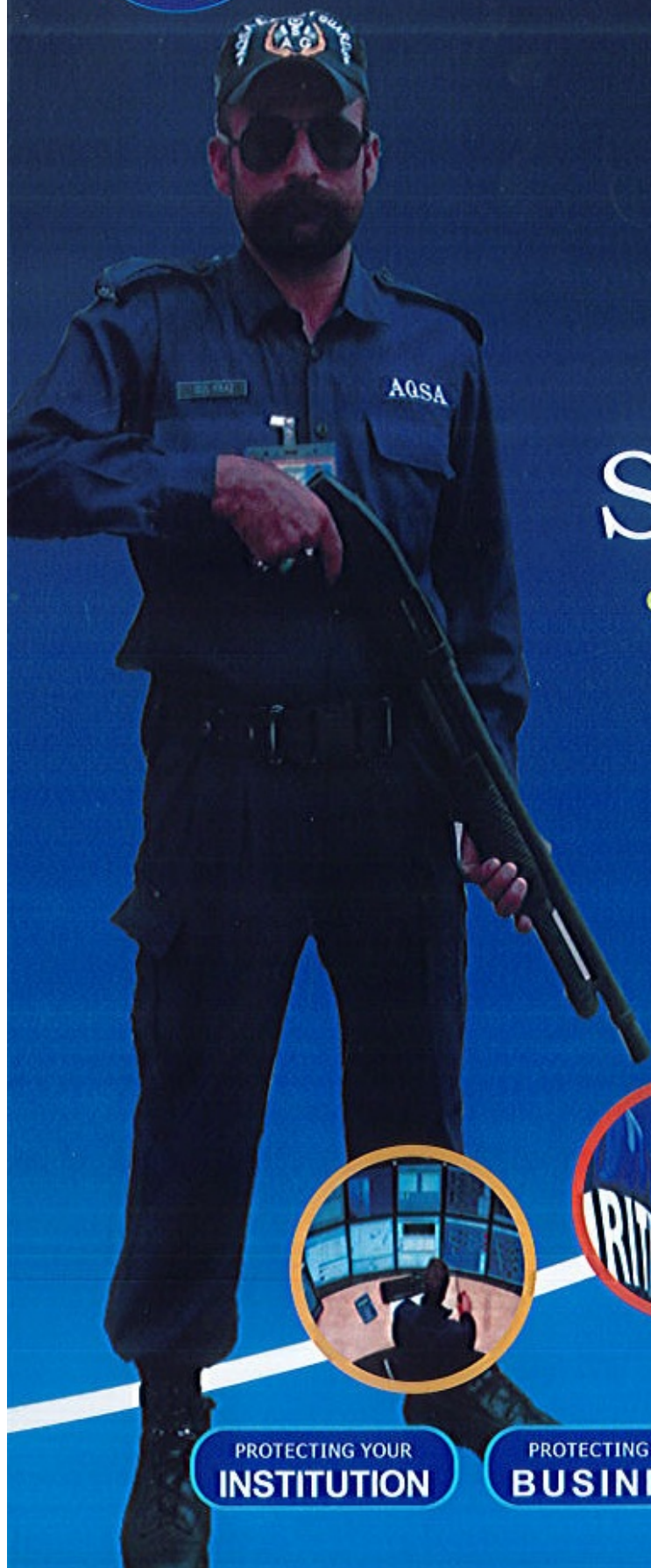

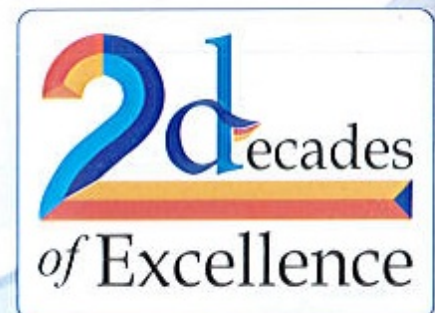

Security Guards are inducted on merit after going through certain procedures and verifications that include testing of physical strength, physical appearance, health, age, duration of military service and character assessment.



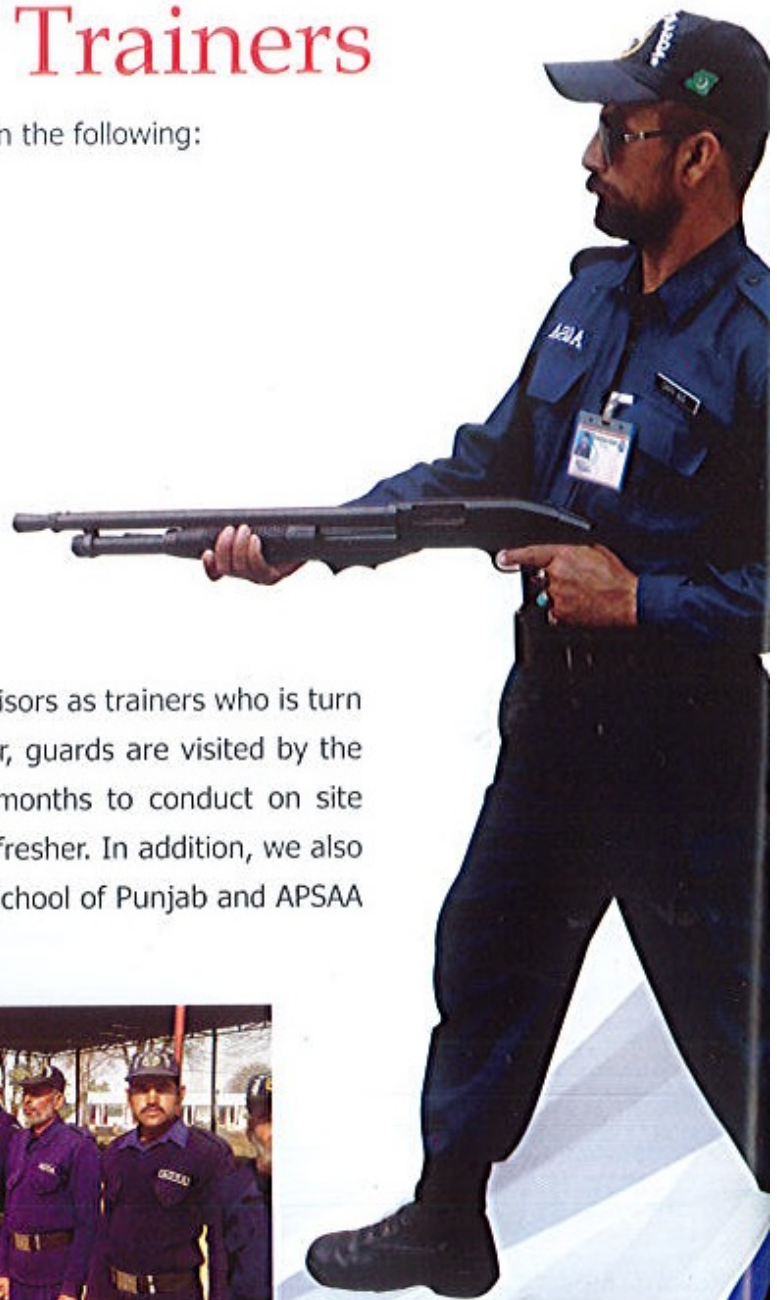

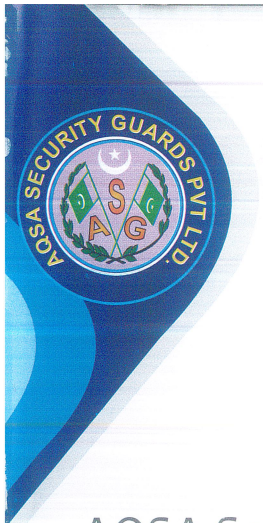

Q.R.F Quick Response Force

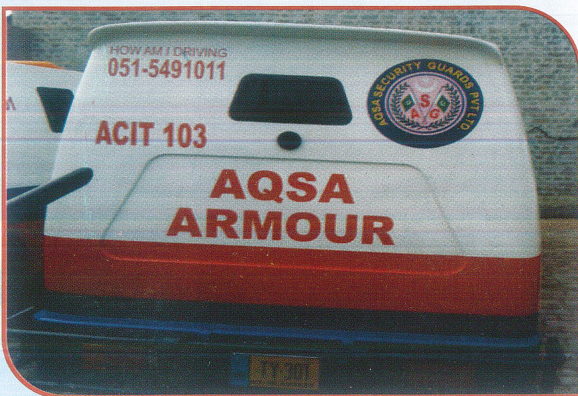
